

Mencap conditions of entry to the 2019 Royal Parks Half Marathon

1. These terms and conditions apply to you if your registration for the 2019 Royal Parks Half is accepted by Mencap.
2. We reserve the right not to accept your application.
3. All runners must be 18 years or older on the day of the event.
4. You enter the Royal Parks Half entirely at your own risk and Mencap shall not be liable for any injury or loss which you may suffer or incur as a result of your participation in this event.
5. You must abide by the rules, instructions and regulations provided by Mencap staff, contracted agencies, officials and police.
6. If you are unsure of your physical ability to take part, you should take medical advice from your doctor to ensure that you are physically fit to participate and it is extremely important that you are realistic about your abilities to participate.
7. To receive a place in the 2019 Royal Parks Half Marathon, you must pay Mencap a non-refundable registration fee of £10, within one week of receiving your offer of the place. Mencap may withdraw this place if payment is not received in time.
8. You also agree to raise £300 in sponsorship which is exclusive of gift aid. The fundraising deadlines for Mencap to receive sponsorship are:
£150 by 22nd July 2019
£300 by 18th November 2019
9. Mencap may withdraw a place if it considers that you are not committed to raising the sponsorship amount.
10. The registration fee is refundable only if the event is cancelled by Mencap. The registration fee will not be refunded for any other reason. If you withdraw you must notify Mencap on 020 7696 6946 or email events@mencap.org.uk.
11. If for any reason you choose not to take part or the event is cancelled, all sponsorship forms and money collected must be forwarded to Mencap and will not be refunded without a written request from individual sponsors.
12. You must pass onto Mencap all monies raised in connection with the event. You can:



- Pay online with your credit or debit card
- Raise funds through JustGiving or VirginMoneyGiving
- Send cheques made payable to Mencap, The Events Team, 123 Golden Lane, London, EC1Y 0RT.

13. By taking part in the event, you confirm that you are happy for your name, footage or photographs taken during your participation in the BMW Berlin Marathon be used to publicise Mencap's work. Any photographs or video footage may be used on Mencap's website, social media networks.

14. In fundraising for Mencap you agree:

- a. To submit all used and unused sponsorship forms
- b. Not to reproduce Mencap's logo without permission
- c. Not to collect in a private place without first obtaining a collector's licence from the local authority
- d. Not to raise funds by carrying out house to house collections
- e. Not to raise funds by conducting a public lottery or raffle
- f. Not to do anything to bring the name of Mencap into disrepute.
